1. Installment Payments will not be allowed on payments of taxes in arrears.
2. I/We have enclosed 6 post-dated cheques for the first six months of the current year, monthly payments equivalent to one twelfth (1/12) of the previous year's current levy, including local improvement taxes (if any). For the last six months of the current year, monthly payments shall be equivalent to one sixth (1/6) of the balance of the tax levy for the current year after deduction of payments for the first six months.
3. This authorized Post-Dated Cheques and Tax Installment Payment Plan may be cancelled upon written notice by me/us not less than 14 days prior to the next due date. Withdrawal from the Tax Installment Payment Plan shall be subject to the provisions of the Tax Installment Payment Plan By-Law.
4. I/We acknowledge that in the event any payment is not honored, penalties will be applied and my/our participation in the Tax Installment Payment Plan may be cancelled, in accordance with the provisions of the Tax Installment Payment Plan By-Law.
5. In the event of a sale of the above noted property, I/We will notify the Town of Oyen in writing not less than 14 days prior to the next due date, to arrange cancellation of my/our payment, and I/We will advise the purchaser of his option to, upon application, make payments by pre-authorized debit or post-dated cheques under the Tax Installment Payment Plan.
6. In the event I/We change my/our bank account I/we will notify the Town of Oyen in writing and complete a new Application /Post-Dated Cheques Form not less than 14 days prior to the next due date and provide any remaining post-dated cheques for the remainder of the term.
7. Any delivery of this Application/Post-Dated Cheques form to the Town of Oyen constitutes delivery by me/us.
8. All persons, whose signatures are required to sign on the bank account listed above, have signed their agreement below.
9. Nothing in this Application/Post-Dated Cheques Form shall be interpreted to relieve the owner/applicant from the obligation to pay any taxes, including penalties, owing to the Town of Oyen or to pay any taxes, including penalties, owing to the Town of Oyen in the manner or on the date or dates for payment established by by-law of the Town of Oyen.
